Cheap rates differentiated for canary residents (registered in the register of municipalities in the Canary Islands) or non-residents, in the following categories of tariffs tickets / entrances to the park (subject to special promotions that are arranged in offer each time on the website and in the process of buying online):

- Adult rate (12 and over).
- Fee disabled adults (16 and over).
- Price children (4-11 years).
- Fee disabled children (from 4-15 years).
- Senior rate (60 and over).

Children under 4 years have free entry.

Tickets / entrances to the park include full visit (zoo and botanical garden) and enjoy performances / shows (like parrots, birds of prey, reptiles and sea lions). Called "special experiences", which will be separate and additional to purchase tickets / entrances to the park amount are not included. Tickets / entries "special experiences" can not be used, independently, being complementary to the visit to the park activities.
