1. CONTENT AND CONFORMITY.

This is configured as the Privacy and Protection of Personal Data (hereinafter "Privacy Policy") which applies to personal data provided through the website www.fuerteventuraoasispark.com (hereinafter, the "Website").

4. RESPONSIBLE FOR TREATMENT. ASSIGNMENT OR DISCLOSURE OF PERSONAL DATA TO THIRD PARTIES.

The collected personal data will not be communicated or transferred to third parties without the consent of its owner, except in cases that satisfy the applicable circumstances established in Article 11.2 of the Data Protection Act, as that communication is available in a law that the treatment meets the free and legitimate acceptance of a

8. DETAILS OF MINORS.
